## swimming pool licences

Get into swimming pool building, renovation, or maintenance with a licence in Swimming Pool Building. Swimming pool repair and servicing licence covers work such as non structural repairs, reticulated pool plumbing and heating systems. To obtain this licence you need to have obtained CPP31218—Certificate III Swimming Pool and Spa Service.

If you are looking for a licence for full pool construction, the first step is to obtain the required units from CPC40808—Certificate IV in Swimming Pool and Spa Building. This licence covers both concrete and prefabricated pools. It also covers associated contract works such as landscaping, pool fencing and repairs and maintenance.

#### what licence should I get?

Before getting a licence, you need to be qualified. Licensing comes down to how and what you're qualified in, so really the question is—what qualification fits your skills and experience the best?

The requirements for a licence application vary by state. In Queensland, you will require both the trade qualification and BSBESB402 — Establish legal and risk management requirements of new business ventures.

In New South Wales, you will need the trade qualification and provide a short work history, which we can do for you.
